Action For Animals Humane Society (AFA) is Westmoreland County's oldest no-kill shelter – we have been matching people and pets for over 30

years! AFA is governed by an all-volunteer Board of Directors and was founded in 1983 to shelter and provide care for abused, abandoned and stray dogs and cats of Westmoreland County.

We are a 501c3 non-profit, non-government funded, no-kill shelter that keeps animals free from the threat of unwarranted euthanasia. AFA rescues and finds responsible homes for around 1,000 animals every year.

AFA is located just outside of Latrobe on Route 217. Our facilities include Tigre Pavilion (cageless open-air cattery), Blessed's Dog Park and walking paths, private visitation rooms, and outdoor covered play areas.

Save a Life Society

Membership in this special society offers peace of mind by providing donors with the option to leave their cat or dog in the care of AFA at the time of the donor's death. Donors who make planned gifts of \$5,000 or more per pet may participate in this program.

AFA will care for the pets until loving, suitable homes can be found, in accordance with placement policies. This arrangement ensures that their pets will continue to receive top-quality care, without the threat of unwarranted euthanasia.

Save a Life Society members should make sure that their wishes are fulfilled by:

 Including necessary information about pets in their estate planning documents, specifically the names, breeds and approximate ages of their animals.

- Making wishes for pets known to a family member or friend.
- Keeping updated notes about pets, including likes, dislikes, medical history or behavior concerns, all of which will be important in finding appropriate homes.
- Keeping medical records and phone numbers of their veterinarian in planning documents.
- Sharing information about pets and intentions with Action For Animals. Remember that the more information AFA attains, the better donors and pets can be assisted.

Bequests

By remembering Action for Animals HS in a will, donors can ensure that their gift continues in perpetuity. The following is suggested language for bequeathing a dollar amount, specific property, percentage or residue, or a pet:

Dollar Amount

"I give, devise, and bequeath to Action For Animals HS of Latrobe, PA \$_____."

Specific Property

"I give, devise, and bequeath to Action For Animals HS of Latrobe, PA (description of property) located at (exact location)."

Percentage or Residue

"I give, devise, and bequeath to Action For Animals HS of Latrobe, PA, all or ___% of the remainder of my

estate after all taxes, liens, and debts have been paid."

Your Pet Relinquished to Save a Life Society Members*

"In addition to my gift of _____ to Action For Animals HS of Latrobe, PA, I also bequeath my cat/dog named _____ to be placed into a suitable home in accordance with AFA's placement policies."

*Note that bequests or other planned gifts must equal or exceed \$5,000 per pet in order to participate in the Save a Life Society.
